Moved by Councilwoman Brown, seconded by Councilwoman, the Board opened the Joint Public Hearing with Village of Montgomery. Motion carried, 5-Ayes, 0-Nays.

Mayor Brescia asked Atty. Dowd to provide a synopsis for the Joint Public Hearing, to hear testimony and receive evidence and information concerning (1) whether the proposed annexation to the Village of Montgomery of certain land as described below in the Town of Montgomery is in the over-all public interest, and (2) the property of the Petition of Michael Aiello, Jr. requesting such annexation, as received by the Village of Montgomery and Town of Montgomery.

Further Notice: The property located in the Town of Montgomery is proposed to be annexed to the Village of Montgomery is represented by the Petitioner as comprising approximately 11.013 acres, as is described by the Town of Montgomery Tax Map as Section 28, Block, 1, Lot, 13.22, being part of the land now or formerly owned by Michael Aiello, Jr.

ESTABLISH PRESIDING OFFICER BY VILLAGE BOARD AND THE TOWN BOARD

Moved by Trustee Andolsek, seconded by Deputy Mayor Scheels, the Board established Mayor Brescia as the presiding officer for this Joint Public Hearing with the Town. Motion carried, 5-Ayes, 0-Nays.

Moved by Councilman Melick, seconded by Councilwoman Voss, the Town Board established Mayor Brescia as the Chairperson for this Joint Public Hearing with the Village of Montgomery. Motion carried, 5-Ayes, 0-Nays.

Mayor Brescia asked Atty. Dowd to provide a synopsis for the Joint Public Hearing.

Atty. Dowd said pursuant to General Municipal Law §705.1 the purpose for this public hearing is for both boards to hear testimony and receive evidence and information which may be presented concerning the petition and the question of whether the annexation is in the over-all public interest, including but not limited to testimony, evidence and information concerning the following:

- a. That a person signing the petition is not qualified therefore, or
- b. With respect to a petition, other than one purporting to be signed by owners of a majority of the assessed valuation or real property, that the person signing such petition do not constitute twenty per centum of the persons residing within such territory qualified to vote for officers of the city, town or village, as the case may be, in which the territory is situated, or
- c. With respect to a petition, other than one purporting to be signed by at least twenty per centum of persons qualified to vote for local officers, that the persons signing such petition do not represent the owners of a majority in assessed valuation of the real property in such territory assessed up the last proceeding assessment roll of, or utilized by, the local government or governments in which the territory is situated, or
- d. That the petition does not otherwise substantially comply in form or content with the provisions of the article, or
- e. That the proposed annexation is or is not in the over-all public interest (1) of the territory proposed to be annexed, or (2) of the local government or governments to which the territory is proposed to be annexed, or (3) of the remaining area of the local government or governments in which such territory is situated, or (4) of any school district, fire district or other district corporation, public benefit corporation, fire protection district, fire alarm district or town or county improvement district, situated wholly or partly in the territory proposed to be annexed.

So, basically have a petition before you by Michael Aiello, Jr. who he represents that he is the sole owner of the property which consist of 11.013 acres; he wishes to annex from the Town of Montgomery into the Village of Montgomery. The question is whether that petition is in proper form, whether he in fact is the sole owner of the property and the overall annexation of the property from the Town to the Village is in the overall public interest of both communities involved; that is what testimony of the public is to be about, if there are any challenges to that, or if there is any information that we need to know about the property and whether or not the petition is proper and that this is not in the overall public interest. Therefore, that is what this public hearing is set to be for.

Atty. Frank said that essentially sums it up, this what this public hearing tonight is about. Eventually both Boards will have to make a determination whether the petition are in proper form and the SEQRA has been taken care of this prior to decisions being issued. Tonight, is to hear from the petitioner, from the public, and from both Boards to be in a position to ask relevant questions with regard to the petitioner whether anything relating to the petition.

Mayor Brescia said on the surface though the criteria have been met. (In audible – speaking too low).

Atty. Dowd said he believes the petition has been filed in proper form and we have certification from the accessor stating that the sole owner of the property is Michael Aiello, Jr. This is the basic criteria here, unless some information from the public would contradict coming forth.

Atty. Frank said correct, in addition to which it is required by the statute; the school district was notified by mail the existence of the public hearing by both the Village Clerk and Town Clerk, and there being no objections by the school district as far as he knows. The Public Hearing has been properly noted and at

which time it is the appropriate to proceed with questions and agrees with the Attorney Dowd that the petition is in proper form.

Mayor Brescia said assuming all of the criteria is met properly with no adverse objections, the Village Board would like to take action two weeks hence. He is not sure what the Town Board schedule is.

Town Supv. Maher replied, it would be next Thursday, and after that it would be the first Thursday in October; which he believes is to be October 7th.

Mayor Brescia asked if there is anything else before we move to public comment. Public comments will be taken and limited to three minutes, please.

Atty. Frank said Mr. Mayor perhaps you like to hear from the petitioner first, allowing them to give their presentation.

Mayor Brescia said OK, he asked RJ Smith if he is giving the presentation.

RJ Smith representing for Michael Aiello, this property is located at the end of Dunn Road. (In audible – speaking to low). The Town and Village line offset this property we effectuated a lot line change that renders this property more usable. The property consists of eleven acres which is behind the Romer property. There are several reasons for the annexation, the first is for the development of the site with the added services, especially for water and having a fire sprinkler system, not having a well on site, obviously we would have a holding tank. Secondly, the Village is set with their comprehensive plan and its zoning, whereas the Town is still working through theirs and are months away from completing the zoning and its final adoption. Lastly, there has been an effort and ongoing collaboration with the Village and the owner of the property at 416 and 211, which is the gateway into the Village. To relocate the business to that site and have the site redeveloped, is more palatable and aesthetically pleasing gateway into the Village. Nevertheless, in all sincerity this property impacts the Village far more than it does to the Town, from the Village standpoint, the Village has more control over the zoning for the site.

Mayor Brescia asked Atty. Dowd if the Village did come up with a standard of construction limitations for the zone.

Chrm. Conero said warehouse criteria have been set in the I-zone, for the size. He believes this is a special zone change for the industrial park zone in the Village Code.

Mayor Brescia said he believes Mike Aiello is aware and Eric Butler is as well. We are trying to promote the new I-1 regulations.

Kelly Naughton said she wanted to make some bullet points for them to know what the ultimate standard is met by the standard annexation for the Town. (In audible – speaking too low). More convincible will they be able to get municipal water and sewer for the property to be developed, to take advantage of those services. (In audible – speaking too low).

PUBLIC COMMENT

Mr. Berger expressed his feelings regarding this annexation is that he is favor of the annexation. The Village Board has gone to great lengths with its comprehensive plan on how they want to gateway to Village to look. Moving the business to Dunn Road, now it becomes an aviation gateway. Ensuring the size of the building and the appearance, he sees what is on 416 and does not want anything like that here.

He hopes what was discussed at many meetings does come true with the landscaping and making it pleasant coming into the Village.

Sylvie Rainaldi, Town resident asked what happened at the Town of Montgomery level regarding this site plan for this property and where they ended up before this annexation came up.

Mayor Brescia said this is not a question-and-answer session but to hear public comment for the annexation.

Sylvie Rainaldi feels the Town should provide the recent history of the property.

Town Supv. Maher said the Planning Board asked the Town building department for an opinion and they were given opinion and further asked the Zoning Board for their opinion, therefore, the Zoning Board gave them a different opinion and it stopped the project and that is pretty much it.

Mayor Brescia said it was discussed moving the facility to Dunn Road. The Masterplan committee was very much in favor of it. He believes there was no dissention or dissent at all from the Village Board.

Ms. Rainaldi mentions the site be proposed for the outdoor construction storage, which is not in the I-1 zoning. She feels the intent is to get around what the Town, Planning & Zoning Boards ruled on.

Town Supv. Maher said the intent to do what is in the best interest of the Town and the Village of Montgomery. He believes this would fall into the high-tech aviation zone.

Ms. Rainaldi feels the property owner is circumventing the system so they can do what they want. She is all for the Village having a pleasing gateway into the Village.

Mayor Brescia thanked Ms. Rainaldi for her comments and called for a motion to close the public hearing with no further comments presented.
