PUBLIC PORTION

Jeff VanZandt felt the recent Planning Board meeting was handled in an unprofessional manner. He further expressed his strong feels that the PB Chrmn should vacate the position, due to the manner in which the recent PB meeting was conducted, and stated having a petition with over 500 resident signatures to support this by next month's meeting. There is a need for transparency. He and the residents protecting Montgomery are concerned with the overdevelopment in the Town and soon to be in the Village of Montgomery. In addition, he is opposed to the KSH building obscuring his view of the horizon during the sunset. This intrusive structure project development is simply not wanted in the backyard of Weaver Street or in the gateway to the historic Village of Montgomery.

Chris Ladanyi also expressed his thoughts and concerns regarding the PB meeting was conducted for the KSH property and the discrepancies on their assessment. The lack of answers is his greatest concern with the Planning Board. His other concern is the assessment, with the full market value is roughly \$200.000, of which they're paying roughly \$2,000 in taxes a year. The property sold for over \$5 million, with this assessment. This is a strange transaction and should send up red flags. I'm looking for help here; at a PB Board meeting they were talking about a 24/7 operation for warehouse attracted traders. There were talks about trucks not tractor trailers, what happened to the compromise? I was in a

collaborative rule for those conversations from happiness to incredibly upsetting that somebody could stand in front of me, tell me something and turn around and do something else. So, thank you for what you do for this village I really do thank you from the heart.
