Dear Retail/Non-Craft Dealer,

The Village of Montgomery is making plans for our *Annual General Montgomery Day* to be held on Saturday, September 7, 2024. The General Montgomery Day Committee has decided to create a special non-craft vendor area specifically for non-craft items. We will allow 15 non-craft vendors to attend the show on a first-come, first-serve basis. Any items that are not hand-made are considered non-craft items. This includes, but not limited to, tee-shirts and clothing, sport memorabilia (baseball cards, Nascar, etc) and specialty foods. The General Montgomery Day Committee has the right to reject any application it feels is not appropriate for General Montgomery Day. The size of each booth spot is approximately 9x17 feet. The vendor fee for the festival is **\$150.00**, which includes one parking permit in a designated vendor parking lot. Space rentals will be assigned on a **first-come, first-serve basis with a maximum of 15 non-craft vendors**.

The Village is planning a full day of activities, including a parade, concert, 8K race, fireworks, a variety of food concessions and many new events and entertainment for this year. The main streets of Montgomery will be blocked off for pedestrians the entire day, allowing ample space for vendor booths to be set up.

If your application is late, it will be subject to a **late fee of \$25.00**. Confirmations for space will be mailed to you by September 2, 2024.
