Cancellations – You may cancel your registration with a full refund(less the \$75.00 non-refundable registration fee) up to two weeks from scheduled registration date (04/27/24). Any cancellations after that date will be a 50% refund (less the \$75.00 non-refundable registration fee). No refunds after June 07, 2024.

Changes – Changes can be made to a campers registration depending on availability up till Friday June 7, no changes will be accepted after June 07, 2024.

Return Checks – Any fees incurred by the Village of Montgomery will be the responsibility of the registrant.

DISCLAIMER:

In consideration of the Village granting and continuing permission for use of its facilities, programs, and personnel, I hereby authorize my child, whose name appears above, to attend the Summer Camp Program sponsored by the Village of Montgomery.
