- Adopt a resolution for certification of Authority, for the Village of Montgomery Board of Trustees, authorizing the Mayor to sign the Municipal Agreement for FY 2023 between the County of Orange through its Office of Community Development and the Village of Montgomery, and for entering into a municipal cooperation agreement with County, in accordance with Section 99-h (2) of New York State General Municipal Law, to apply for and receive Community Development Block Grant ("CDBG") funds (CFDA# 14.218) from the United States Department of Housing and Community Development (“HUD”) under Title I of the Housing and Community Development Act of 1974, ("HCD Act"), as part of the Orange County Urban County Consortium for the Fiscal Year 2024, pursuant to 24 C.F.R § 570.501(b) and § 570.503, this separate agreement is necessary for the Municipality to receive the CDBG funds through the County to implement community development activities. Pursuant to the Agreement, the Municipality will receive \$47,125 for Senior Center Improvements, specifically replacement of the air conditioning system.
- Authorize the mayor to submit first payment for Senior Center Improvements, in the amount of \$73,805.50.
- Consider approving a new phone system for the Village offices.
- Consider adopting a cyber response plan.
- Accept the resignation of Police Officer Matthew Mahoney effective September 22, 2024.
